Minutes of the Meeting of the Parish Council of Hodnet, held on Thursday, 17th January 2019 at The Lyon Hall, Hodnet.

- **7/1 Welcome and Apologies –** Apologies were noted from Cllrs Steve Alden and Karen Calder
- 7/2 **Declaration of Interest –** No personal or pecuniary interests were declared
- 7/3 Public Session There will no members of the general public present
- **Minutes t**he Minutes of the Parish Council Meeting held on 6th December 2018 were unanimously approved.
- 7/5 Clerk's update regarding on-going matters not on the agenda The Clerk updated councillors as follows:
 - i. proposed AED in Marchamley discussions continuing with Western Power and E-ON regarding responsibility for installing switch. Councillors confirmed that the Parish Council would not make any purchases on behalf of the community-led AED to avoid complications with VAT and ownership issues, other than the required switch.
 - ii. quotes being obtained for car park repairs at Lyon Hall and Hodnet Club Clerk to arrange temporary repairs
 - iii. quotes being awaited for repairs and improvements at the Recreation Ground Clerek to arrange for mole issue at Recreation Ground to be addressed
 - iv. A letter had been sent to Hodnet Social Club regarding outstanding rent for 2018-19.
- 7/6 Unitary Councillor Report there was no Unitary Councillor report
- 7/7 Report from Hodnet Parish Council representatives at recent meetings -Councillor Chris Mackie reported on a meeting regarding proposed plans for house building developments by 2036. The overall requirement is to build 29,000 new homes, and the new proposed figure for Hodnet was a total of 105 houses with 53 already approved, including Station Road. The proposed location of new housing is in an area between the Primary School and The Crescent. It is also proposed to change the ratio of affordable to market value housing to 20% of each development.
- 7/8 Planning
 - i. To consider the following planning application:
 - a.18/05777/FUL: 4 Shrewsbury Street, Hodnet, Shropshire, TF9 3NP: Part demolition of existing single storey store building and erection of roof over high level brickwork to create off-road parking under cover. Council raised no objection, but suggested that the design be more sympathetic with a curved arch in the vicinity
 - b. 18/05892/FUL: Erection of one dwelling; formation of access; installation of package treatment plant: Proposed Dwelling To The East Of The Bowling House, The Avenue Peplow Market Drayton Shropshire. **Council decided to make no comment**

- **7/14 Parish Plan** Council deferred this item until the February meeting to allow time for a discussion with a member of Community Enablement Team.
- **7/15 Matters relating to Council Staff** Council agreed to recognise Mr Wellings work for the Council, and to do so at the February meeting
- **7/16 Parish Website** Cllr Chris Mackie and the Clerk reported that there had been one reply to the advertisement in the Parish Magazine, which although encouraging did not present the required solution. The web group would meet again to agree a proposed way forward for Council to consider at its February meeting.
- 7/17 Correspondence To enable the Council to discuss correspondence received:
 - i. Police and Crime Commissioner consultation it was agreed that the Clerk would respond positively to the proposed increase in the number of police officers and accepted the consequences on Council Tax payers
 - ii. Shropshire Council Bring Banks Consultation. Council was disappointed by the proposal and agreed that a letter should be sent stating this is an essential service to the community and objecting to the proposal **Clerk to action**
 - **7/18. Parish Matters** Cllr Freeman informed Council that Hodnet Primary school had been inspected by Ofsted and maintained is 'good' rating, and was deemed on its way to 'outstanding'.
